



Ductless Heat Pump (DHP) & Ducted Mini-Split Installation Form

Homeowner installations do not qualify. All sections must be filled out by the installer at the time of installation. A copy of this completed form and the purchase receipt or invoice must be received within 90 days from the date of install to qualify for a rebate. Only one rebate may be claimed per home.

Eligibility Guide for DHPs and Ducted Mini-Splits: Ducted Mini-Splits do not include homes with whole house centrally ducted systems. See PTCS Air Source Heat Pumps for further information on whole home centrally ducted systems.

All systems must:

1. Be installed on a dedicated electrical circuit,
2. Have refrigerant line protection on the entire length of exterior and insulated refrigerant lines,
3. Be installed in accordance with manufacturer specifications, including adherence to proper refrigerant charging and,
4. If installing a single head DHP, **Check Box 0**, the contractor must have received the contractor orientation available at goingductless.com/partners.
